



TERMS & CONDITIONS OF THE CONTEST

“3 Days to FALL in LOVE with POLAND”

These Terms & Conditions govern participation in the contest “3 Days to FALL in LOVE with POLAND,” hereinafter referred to as the “Contest,” organized by the Polish National Tourist Office North America in Chicago, with its office at:

I. General Provisions

1. The Contest begins on December 9, 2025 and ends on December 19, 2025 at 11:59 p.m. CST.
2. Participation in the Contest is free of charge.
3. Each Participant may submit one entry during the Contest period.
4. Winners will be announced no later than December 22, 2025 via email.
5. A Winner must confirm acceptance of the prize within 14 days. Failure to respond results in forfeiture.
6. Participants must be 18 years of age or older.
7. The Contest is open only to individuals residing in the United States and Canada. Employees of the Organizer and their families are not eligible.
8. Participation constitutes acceptance of these Terms & Conditions.
9. The Contest is open only to individuals residing in the United States and Canada. Employees of the Organizer and their families are not eligible.
10. The Contest is organized and conducted on the Organizer’s official Facebook page Poland.Travel (Poland Travel USA & Canada). Winners will be publicly announced on Facebook

no later than December 22, 2025, and will also receive notification via the email address provided in the entry form.

II. Participation Rules

1. Any eligible individual submitting a complete entry via the official Google Form is considered a "Participant."

2. Each Participant must prepare a 3-day travel itinerary showcasing Poland, in which each day includes at least three (3) different activities representing:

- Culture/History
- Culinary/Leisure
- Sport/Nature

3. The entry must include the following components:

A. Selected City/Region (Short Answer- Required)

Participants must indicate the main city or region they plan to visit in Poland (e.g., Kraków & Tatra Mountains, Tri-City, Warsaw, Wrocław or others).

B. Day-by-Day Itinerary

Participants must describe a full 3-day plan including at least three distinct activities per day across Culture, Culinary, and Sport/Nature categories.

Examples:

Day 1:

- Morning- visit Wawel Castle (Culture)
- Lunch- traditional restaurant (Culinary)
- Afternoon- kayaking on the Vistula River (Sport/Nature)

Day 2:

At least three activities across the same categories.

Day 3:

At least three activities across the same categories.

C. Justification (Long Answer- Required)

A 100-150 word explanation describing why the itinerary is compelling and how it would make the Participant “fall in love with Poland.”

4. Submissions missing any required elements may be disqualified during the Formal Review stage.

5. Only complete entries will advance to Creative Evaluation. The Jury evaluates:

- creativity and originality,
- clarity and coherence,
- authenticity and understanding of Polish tourism,
- quality of the justification.

6. No correspondence regarding evaluation or Jury decisions will be conducted.

III. Prizes

2. Matters not covered herein will be resolved by the Organizer.
3. These Terms & Conditions enter into force on the date of publication.

VIII. Prizes Provided by Partners – Additional Provisions

1. Nature of Prizes

Hotel stays and flight vouchers/tickets are funded and fulfilled by third-party Partners/Sponsors of the Contest, specifically the respective hotels and LOT Polish Airlines (collectively: the "Partners"). The Organizer is not the supplier of these services and is not responsible for their execution.
